

LauderDoodles Health Warranty and Purchase Agreement

Updated version 3/16/26: applicable to all puppies/dogs placed by LauderDoodles on or after 1/1/21.

Guarantee: The Buyer has 3 business days, from the time of receiving the puppy, to have it evaluated by a licensed veterinarian. If the veterinarian diagnoses any disease or physical defect outside normal puppy growth stages, the diagnosis must be in writing and LauderDoodles must be notified by email within 3 calendar days of the exam. We, LauderDoodles, will refund the **purchase price ONLY** of the puppy if the puppy is returned (we will pick the puppy up at our expense) or pay for the treatment (based on what our current veterinarian/vet clinic would charge for the treatment and/or medications). The Buyer must request return or reimbursement within 3 calendar days of the exam and the request must be via email. Exceptions to reimbursement for treatment are treatments/medications outside of those recommended and common for our current veterinarian/vet clinic.

Warranty: Written diagnosis of a genetic disease or debilitating congenital physical defect, other than those specifically excluded below, by a licensed veterinarian prior and up to the puppy's 2nd birthday may result in a full refund of the **purchase price ONLY** and the offer to take the dog back (not required for refund). LauderDoodles reserves the right to obtain a second, corroborating diagnosis from a licensed veterinarian of their choosing, which may include a full review of medical records and any diagnostic evaluations used by the Buyer's licensed veterinarian to diagnosis the defect or disease, prior to refunding the full purchase price. A diagnosis of hip or elbow dysplasia must be confirmed by submission of x-rays to OFA from the Buyer's licensed veterinarian and at the Buyer's expense. PennHIP evaluations will not be accepted. LauderDoodles has 60 days from receipt of the initial diagnosis from the Buyer's veterinarian, to confirm the diagnosis and give a full refund or deny the refund based on a non-corroborating evaluation by a second licensed veterinarian. In the case of a non-corroborating diagnosis, the Buyer will receive a written statement as to why the refund was denied. This warranty does not include metabolic or endocrine disorders, allergies, viral illnesses, bacterial infections, parasite infestations, improper bites, hernias, hypoglycemia, giardia or coccidia. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury. This warranty is not transferable unless the puppy is returned to LauderDoodles from the Buyer.

Return Policy: LauderDoodles will refund the **purchase price ONLY**, minus \$400 (\$700 for professionally trained) for time/expense/re-homing of the puppy, if it is returned in good mental and physical health within the first week of purchase **due to allergic reactions** from the family members (Buyer's immediate family living in the house with the dog). The Buyer must have confirmed to LauderDoodles prior to purchasing the puppy, that someone in the immediate family was diagnosed with dog allergies from a licensed medical doctor. Puppy must be returned at the Buyer's expense.

LauderDoodles will always accept a puppy/dog, which was purchased from us, to be returned to us at any point in the puppy/dog's life. A written statement of why the dog is being returned as well as all health records, any training certificates and a signed transfer of microchip registration must accompany the puppy/dog so that we can best accommodate its needs and work to place it in a new home. **If the puppy/dog is returned for reasons other than those outlined in the Guarantee and Warranty above, there will be NO REFUND of purchase price of the puppy/dog.**

Buyer's Responsibility:

1. The Buyer agrees that their Labradoodle will be housed indoors, will have a fenced yard and will not be tethered.
2. The Buyer agrees to feed their Labradoodle only a premium quality food.
3. The Buyer agrees to keep their Labradoodle at a healthy weight.
4. The Buyer agrees to make and keep all puppy and annual veterinary appointments for their Labradoodle, keep all immunizations current according to the guidelines of the AVMA and properly administer heartworm preventative.
5. The Buyer agrees to provide basic obedience training with their Labradoodle within the first year of owning their dog.
6. The Buyer agrees to postpone strenuous, repetitive exercise until after their Labradoode is over one year of age.
7. The Buyer is REQUIRED to spay or neuter their puppy before or during the 6th month of age UNLESS LauderDoodles has a specific sales agreement with the Buyer that this puppy is being sold as a breeding dog (separate contract applies).
8. The Buyer agrees to contact LauderDoodles immediately if the Buyer determines they are unable to keep their Labradoodle for any reason. LauderDoodles will work with the Buyer to determine how to re-home the dog.
9. The Buyer agrees to never place the Labradoodle in a shelter, pound or similar facility or research laboratory.
